

**DECLARATION OF DOUGLAS
LOWER**

I. WALLACE OFFERS BRIBE

I DOUGLAS LOWER CERTIFIES THAT I AM OVER THE AGE OF 18 AND THE FACTS STATED
HEREIN ARE TRUE TO THE BEST OF KNOWLEDGE.

1. On or about March 20, 2008 Mr. Mark Phillips sent me an email requesting that I set
up a meeting for Ms. Jan Wallace with Robert Arnold. Shortly after I received a phone call
from Mr. Phillips where he proceeded to tell me that Jan Wallace had stolen contact
information from his computer and he feared that it may have been his address book. Mr.
Phillips specifically told me that Ms. Wallace was making threats to him that she was going to
make-up lies to Mr. Arnold unless I was able to set up a meeting.

2. On or about March, 24 2008 I was asked by Mr. Wallace to have lunch in Belltown.
Shortly after sitting down, Ms. Wallace asked me if I could arrange a meeting with her and Mr.
Arnold to discuss an investment in Davi Skin. I told her that I did not have the ability to set up
any kind of meeting with him. Ms. Wallace asked if my wife, Maureen, could set something up
so I gave Ms. Wallace a similar response. Ms. Wallace said that Maureen could set it up
because she worked for Mr. Arnold. Nevertheless, I told Ms. Wallace, that despite the
connection, Mark Phillips had met and received an invitation by Mr. Arnold prior to my
professional relationship, and therefore my assistance in communications was not the cause of

1 any past or present investment. I proceeded to tell Ms. Wallace that, regardless of my
2 relationship, access was not ethical, and after badgering me, I told her that Maureen had in fact
3 left his employment a year prior.

5 3. Ms. Wallace then offer me 566,000 shares of Davi stock, in Arch Ltd. (anonymous
6 nominee off-shore company) if I could arrange a meeting for her with Mr. Arnold. Again, I
7 told her that it was simply not possible. Ms. Wallace was visibly not happy.

9 4. After returning to my office, I called my wife Maureen and told her about my
10 conversation with Ms. Wallace. I asked her to warn Julie de Haan or Christy Wise, now
11 personal assistant to Mr. Arnold, to inform her that Ms. Wallace is trying to get a meeting with
12 him and to be on notice in case Ms. Wallace attempts to schedule time with him. Within a few
13 hours, Christy called Maureen to let her know that Ms. Wallace had turned up at the office with
14 a basket of Davi products and some flowers for Christy. Ms. Wallace requested that she be let
15 in to meet with Mr. Arnold. I was informed that Christy denied this request.

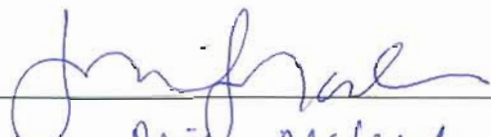
