FROM SEARCH ENGINE RESULTS**

In this action, defendants MARK E. PHILLIPS aka MARK REYNOLDS aka JUANITA JARDINE; JAMES M. SEYLER aka MIKE SEYLER; SPECIALIZED CORPORATE INVESTIGATIONS, LLC dba SEATTLE SCAM DETECTIVES, having been served with the Summons and Complaint and having failed to appear and answer the Plaintiff's Complaint filed herein, the legal time for answering having expired, and no Answer having been filed; the Default of each of the defendants having been duly entered according to law and the court having found that proper process has been performed, Judgment is hereby entered against Defendants pursuant to the prayer of the Complaint.

WHEREFORE, IT IS HEREBY ORDERED, ADJUDGED AND DECREED that Plaintiff, KYLEEN E. CANE shall have and recover from defendants MARK E. PHILLIPS aka MARK REYNOLDS aka JUANITA JARDINE; JAMES M. SEYLER aka MIKE SEYLER; SPECIALIZED CORPORATE INVESTIGATIONS, LLC dba SEATTLE SCAM DETECTIVES

5 2. Exemplary damages in the amount of \$2,000,000.00 on Plaintiff's claim for tortious
6 claims for Defamation, Interference with Prospective Economic Advantage and Invasion of
7 Privacy - False Light;

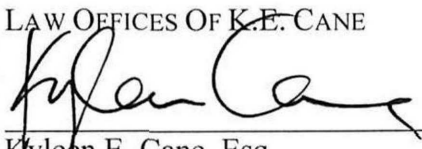
8 Additionally, because of the false, offensive and defamatory nature of the offending
9 websites and blog posts published by Defendants, IT IS HEREBY ORDERED ADJUDGED AND

14 wherever published, be removed from their existing host on the internet and delisted by the various
15 search engines (including Google, Yahoo and Bing) so as to no longer be provided in their search
16 engine results. The Parties are hereby ordered to accomplish this delisting and removal of the
17 Offending Websites by whatever means possible and are hereby enjoined from re-posting or re-
18 publishing any of the materials contained on the Offending Websites.
