4 5. There are no setoffs or counterclaims in favor of the judgment debtor.

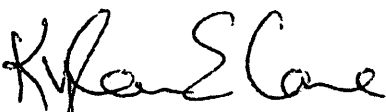
5 6. The exact amount due on the judgment is \$4,888,924.78, plus interest at the legal rate
