Declaration of Kelly Black

I, Kelly Black, do hereby declare:

1. The following facts are within my personal knowledge and if called upon to testify in a court of proper jurisdiction, I could competently testify thereto.
2. I am not a party to this action. I am a shareholder of Secured Diversified Investments, Ltd.
3. Since February 1, 2006, Mr. Clifford Strand contacted me by phone three or four times.
4. In the last conversation in beginning of March, 2006, he told me a about shareholders' lawsuit which would be filed against Ms. Jan Wallace. He alleged that Ms. Wallace was stealing the company, that she issued 15 million shares of company stock to herself and that she deliberately moved the office to Arizona to prevent Mr. Strand from contacting her.
5. In addition he stated Ms. Wallace stole two million dollars from the sale of the Cannery and that she "pocketed the money" and did not disclose the sale of the property in Form 8K.
6. Mr. Strand stating they were trying to hold an emergency shareholder meeting but could not reach anyone. Mr. Strand asked me if I would talk to the lawyer handling the lawsuit and join the suit. I told I would speak to the lawyer however to date no one has contacted me.

I declare under penalty of perjury under the laws of the State of California that the foregoing is true and correct.
